CALL TO ORDER: The meeting was called to order at 8:33 am

APPROVAL OF MINUTES

MOTION: Trustee Sanfason moved to accept the January 18, 2020 Board of Trustee Meeting Minutes as presented. Seconded by Trustee Singelais. **The motion passed unanimously.**

TREASURER'S REPORT

Trustee Fowler reported that as of the end of January, the Overall Budget was 71.23% spent, the Operating was 70.85% spent and we are 75.00% through the Fiscal Year. The Operating Account showed a balance of \$57,882 the CD Money Market Account had a balance of \$997,718 and Petty Cash showed a balance of \$300 for a total of \$1,055,899.

MOTION: Trustee Oreto moved to accept the Treasurer's Report for January 2020. Seconded by Trustee Singelais. **The motion passed unanimously with Trustee Fowler Abstaining.**

DIRECTOR OF FINANCE AND ADMINISTRATION

Amy Harris reported:

- Water Shut Off Notices: In January, we sent out 79 water shut off notices and turned off one, which has been turned back on. In February, we sent out 69 notices.
- Collection Agency: In February, we collected \$111.
- **Bank Collections:** We collected \$2,300 in February, requiring a write off as we made a settlement agreement with the bank.

MOTION: Trustee Oreto moved to write off \$782.28 on Lot 0899. Seconded by Trustee Fowler. **The motion passed unanimously.**

- Meeting Room TV: Up and running! Will work improving the delay for next month.
- Newsletters: Need them by March 13th for the Annual Mailing.

SECURITY REPORT

Amy Harris reported for Carol Carey:

- The home security company for one of the Leisure Lane residents called to report a burglar alarm. Carol checked it out and there were no issues. Member was thankful.
- Deputy Sanborn reported a snow mobile went into the lake. The owner was able to get out.

PUBLIC WORKS MANAGER REPORT

Scott Davis reported:

• Quotes for Weights: Went to four companies for quotes for the weights for the water crossing. Three of the four companies replied. We need 160 weights and the cheapest quote was a little over \$150 each which for a total cost of about \$26,000. We also need turbidity curtains and some other items for about \$9,000.

MOTION: Trustee Sanfason moved to approve up to \$38,000 out of capital improvement to fund the additional items for the water crossing. Seconded by Trustee Dawson. **The motion passed unanimously.**

- **Clubhouse 1 Expansion:** Got some quotes back for expanding space at Clubhouse 1. Still waiting for one last quote.
- Equipment Repairs: Crew has been working on maintaining equipment.
- Mechanic: Offered the job to a crew member and he isn't interested.
- Water Production: Passing all the tests. Production is around 9 million gallons.

OLD BUSINESS

FY21 Budget Discussion

Trustee Fowler presented the Budget as prepared to date.

MOTION: Trustee Fowler moved to approve the FY21 Budget as presented; dues will be in the amount of \$1,060.00 for a house, \$740.00 for an undeveloped lot and \$162.00 for an extra lot and to set the interest rate at 15%. Seconded by Trustee Singelais. **The motion passed unanimously.**

Lake Improvement Committee

Trustee Fitzpatrick reported:

- We still must do a permit by rule.
- The grant has been submitted requesting \$40,000.
