#### APPROVAL OF MINUTES

**MOTION**: Trustee Oreto moved to accept the May 16, 2020 Board of Trustee Meeting Minutes as presented. Seconded by Trustee Fitzpatrick. **The motion passed unanimously.**

**MOTION:** Trustee Fitzpatrick moved to approve the email votes for keeping clubhouses closed. Seconded by Trustee Martel. **The motion passed unanimously.** 

# TREASURER'S REPORT

Trustee Fowler reported that as of the end of May, the Overall Budget was 8.34% spent, the Operating was 8.64% spent and we are 8.33% through the Fiscal Year. The Operating Account showed a balance of \$75,540 the CD Money Market Account had a balance of \$1,381,089 and Petty Cash showed a balance of \$300 for a total of \$1,456,929.

**MOTION**: Trustee Martel moved to accept the Treasurer's Report for May 2020. Seconded by Trustee Singelais. The motion passed unanimously with Trustee Fowler abstaining.

## DIRECTOR OF FINANCE AND ADMINISTRATION

Amy Harris reported:

- Water Shut Off Notices: We have not been doing any WSO Notices or WSOs.
- **Bank Collections:** We collected \$79 in May.
- Year End Outstanding Dues: The Board Package has a breakdown of all the unpaid dues at end of Fiscal Year. In the miscellaneous category we have two members to discuss. One property we need to write off where the member filed for bankruptcy. The second property would be a member that we allowed for a very liberal payment plan. We suspect it will be in foreclosure soon.

**MOTION**: Trustee Martel moved to write off \$772.66 for Lot A553. Seconded by Trustee Fowler. **The motion passed unanimously.** 

- **Fence:** We sent a denial letter and have not heard back.
- May Late Fees: We had 270 members that did not pay May dues. The Board has indicated they do not want to charge late fees for June.
- **Clubhouse improvements:** Security cameras are installed. Flooring is on hold because materials are not available.

### SECURITY REPORT

Carol Carey reported:

- Received a call that there were kids throwing stones and swimming at the Bay Cove Boat Ramp.
- June 5<sup>th</sup> received a call about the parking on Love Lane. She is asking people to park on Old Portland Road. Next step may be to tow vehicles.
- Call from Thomas Grillo at 55 Leisure Lane regarding a boat tied up at Beach 6.
- Three cars have been broken into on New Dam Road.
- Gary Zuger has called the sheriff regarding people fishing in the lake in front of his house. The sheriff said they are not doing anything wrong.

### PUBLIC WORKS MANAGER REPORT

Scott Davis reported:

- **PW2 Flushing Hydrant:** The crew recently installed a small 2" hydrant onto the blow off on PW2. This will help with flushing in the winter.
- **Transmission Main Update:** The crew has installed a couple hundred feet of 12" water main towards the water as well as a hydrant to help with firefighting.
- **Fitness Center Expansion:** With the closure of the fitness center we had a contractor work on expanding the cardio room. We have a new rowing machine and a rowing machine.
- **Grading:** Its difficult to grade in such dry conditions.
- Equipment Repair/Inspection: Tyler continues to keep the fleet going.
- Water Production: Production for May was 12.4 million gallons; up due to dry conditions and nearly full occupancy due to the pandemic. We are going to advise members we are at level 2 water usage guidance.

# **Employee Health Insurance Renewal**

**MOTION**: Trustee Fitzpatrick moved use the premium Indeed.com service for three months funded from Emergency Contingency. Seconded by Trustee Martel. **The motion passed unanimously.**
