## APPROVAL OF MINUTES

**MOTION**: Trustee Oreto moved to accept the May 21, 2022, Board of Trustee Meeting Minutes as presented. Seconded by Trustee Fitzpatrick. **The motion passed unanimously.**

## TREASURER'S REPORT

Trustee Fowler reported that as of the end of May, the Overall Budget was 7.51% spent, the Operating was 7.75% spent and we are 8.33% through the Fiscal Year. The Operating Account showed a balance of \$81,181 the CD Money Market Account had a balance of \$1,635,789 and Petty Cash showed a balance of \$300 for a total of \$1,717,270.

**MOTION**: Trustee Fitzpatrick moved to accept the Treasurer's report as presented. Seconded by Trustee Martel. **The motion passed with Trustee Fowler abstaining.** 

## DIRECTOR OF FINANCE AND ADMINISTRATION

Amy Harris reported:

- Water Shut Off Notices: We sent out 137 notices for June which is typical for this time of year.
- **Audit**: The audit is completed and we are waiting for the results and hope to have them for the July meeting. The auditors have asked for us to review to future cost replacement over the next 10 years.

**MOTION:** Trustee Fowler moved to increase the estimated future replacement costs as follows: Buildings 100,000, Furniture 75,000, Vehicles 1,000,000. Seconded by Trustee Berry. **Motion passed unanimously.** 

- **Insurance Renewal:** Chalmers requested quotes from alternative markets, but nobody wanted to quote us due to some risks they do not know how to manage.
- Lori Lane Lot: The member is in collections and there are numerous trailers on the property. The amount of stuff on the properties is growing. Send a notice he is in violation of deed restrictions.

**MOTION**: Trustee Fitzpatrick moved to send a notice that they are in violation of deed restrictions. Seconded by Trustee Berry. **The motion unanimously.** 

- **House with a fence**: There is a house on Crescent with a fence that did not obtain a permit request. Board wants to send a letter to them about getting permission.
- Old Country Way: The water service was located.
- Love Lane Parking Issue: Member came in and complained about parking up there.

- **Beaver Dam:** Working on ditching and road improvement.
- New House Services: Put in new water services on Leisure Lane and Fisher.
- **Grandview Drive:** Did a new culvert on Grandview.
- Garage: The crew has been working on new equipment updates, getting plows etc. ready, lost brakes on John Deere grader and they are working with John Deere to fix it. They replaced the wood deck on the hay trailer.
- **Abbotts**: They have more stainless bodies in stock. It will be \$5,500 to get one for the FL80. Motion Alan, George to purchase sander for up to \$6,000 unanimously.
- New Well: They are going to put in the casing and glass pack to run test on water in about a month.
