APPROVAL OF MINUTES

MOTION: Trustee Oreto moved to accept the September 19, 2020 Board of Trustee Meeting Minutes as presented. Seconded by Trustee Berry. **The motion passed unanimously.**

TREASURER'S REPORT

Amy Harris reported for Trustee Fowler that as of the end of September, the Overall Budget was 43.24% spent, the Operating was 41.96% spent and we are 41.67% through the Fiscal Year. The Operating Account showed a balance of \$33,098 the CD Money Market Account had a balance of \$1,254,949 and Petty Cash showed a balance of \$300 for a total of \$1,288,347.

MOTION: Trustee Oreto moved to accept the Treasurer's Report for September 2020. Seconded by Trustee Singelais. **The motion passed unanimously.**

DIRECTOR OF FINANCE AND ADMINISTRATION

Amy Harris reported:

- Water Shut Off Notices: We sent out 33 notices for September and shut off one that we believe is seasonal. In October we sent out 68 notices.
- **Collections**: We collected \$1,621 from one house foreclosure.
- Camper on Kennedy Owner called and was very antagonistic. She indicated she has no intention of moving it.
- New Truck Partners Bank issued a commitment for a loan at 3.6% for 5 years. They need the serial number and insurance information. We need to make an appointment with Dave to go to the bank for the closing.
- **Clubhouses** Clubhouse 1 is getting used while clubhouse 2 is not getting very much usage. We would like to adjust appointments to an hour.

SECURITY REPORT

Carol Carey reported:

- Complaint from resident near the tennis courts about teens at the courts being loud late at night.
- Call from Leisure Lane resident about their neighbor.
- Call from Fox Ridge resident about gun shots.

PUBLIC WORKS MANAGER REPORT

Scott Davis reported:

- **Transmission Main Update:** The main has been installed across the lake and the water lines will be flushed next week.
- **Well 3 Test Drilling**: Dirigo Engineering will start this the week of October 19th.
- Pavement Crack Repairs: Zebra Striping has completed the sealing on Old Portland Road and Old Country Way.

- **Equipment and Plow Repairs**: The mechanics have been working on getting the equipment winter ready when they have not been working on the water crossing.
- **Limerick Parcel Lockers**: The Limerick Post Office has provided us with some additional parcel lockers to place throughout the community.
- Water Production: Production for September was 11.6 million gallons.
